#### **GENERAL ESTIMATE DATA**

- :: Header includes all the customer data, including customer's name, address, vendor, payment terms, shipping data, quantity, estimate's description, delivery date, etc.;
- :: Workflow, according to a pre-defined approval sequence;
- :: Generating work order after approving the order;
- :: Estimate request information containing the general characteristics of estimate work:
- :: Electronic management of all the documents that may be related to a given case;
- :: Managing multiple versions and links between estimates, technical data-sheets and customer orders and job orders;







#### **JOB DEFINITION**

- :: Insertion of parameters fully adjusted to the customer;
- :: Definition of label format;

#### **DEFINITION OF DIE-CUTTING**

:: On the die-cutter settings, the estimator may attribute to each customer a type of die-cutter. To do so, he will have to introduce some data about the height and width of the label, label distribution, spaces between the labels, etc.;

:: While creating an estimate, the system will attribute by default the die-cutter associated to the customer. However, the estimator may change it or even create a new one.

#### **DEFINITION OF CATEGORIES/ NUMERATION MANAGEMENT**

- :: Definition of categories;
- :: Definition of colours;
- :: Varnish selection;
- :: Managing categories numeration.

#### DIRECT PRINTING/STAMPING

- :: The system suggests the machine for printing/stamping;
- :: By selecting the desired machine, the estimator may analyse printing and die-cutting plan;
- :: The system will automatically perform the calculation of the printing and stamping cylinders, the plate and the die-cutting format, space between the labels, etc.;
- :: Automatic calculation of the stamping plan;
- :: Managing of stamping overload/online/offline;
- :: Calculation of the revolution values, time/cost, printing film, etc.;
- :: Automatic calculation of the number of reels and the reel diameter;
- :: Analysing the comparatives of the Cost Scenario.
